- 4 images in either digital or hard copy: 1 of the completed mosaic
2 showing details of the mosaic
1 of the original subject/ inspiration
- Digital images should be saved as JPEGs and be able to be opened on PC format.,
300 dpi & max pixel dimension of 800, max size 1.5mb.

Saved as: surname_firstname_title of work (e.g.: Smith_Simon_Sunset).

Entries must also include the entry form, the entry fee and a CV (if applicable), detailing the artists professional practice and exhibition history.

A 50 word Artist Statement describing where your inspiration came from, and why you have chosen this sea creature, or part thereof, as your inspiration

All entries submitted must be the ORIGINAL WORK of the artist,

have been executed since 1 JULY 2008

not previously shown in a MAANZ Exhibition

NO COPY OF ANOTHER MOSAIC WORKS ALLOWED

The submitted PHOTOS, CD, curriculum vitae, entry form and entry fee become the property MAANZ.

THE SELECTION FOR HANGING

Due to the variable quality of images sent for consideration in the exhibition (Mosaics pose many issues when photographing) it is the intention of the selection committee to refrain from decisions until the work is in situ.

Therefore **NO pre-selection process will take place.**

All works will be delivered to the stated address by the date & time indicated. However not all works may be hung. Therefore the committee reserves the right to reject any entry. Late delivery of entries also may not be considered for the exhibition. No reasons will be given and no correspondence will be entered into.

There is no refund of entry fee for work not selected for hanging. The fee is retained as a contribution to costs of receiving, processing and assessing work. Misinterpretation of the entry form does not constitute reasons for a refund.

THE SELECTION for TOUR

A maximum of 16 art works will be selected to be exhibited in NSW, VIC, ACT, QLD & SA. They must be available for travel for a period of 14 months. The Judging Panel may in its discretion choose less than 16 works for touring; the Judging Panel's decision will be final and NO CORRESPONDENCE will be entered into.

The works for Touring will be selected only from the exhibited works.

Artists selected for touring ONLY will be notified of their selection by email or phone on Saturday 10th October after the announcement at the Symposium Opening. Selected works will then be viewable on the at www.maanz.org
